

MINUTES OF THE MAYOR & COUNCIL REGULAR MEETING OF JUNE 22, 2005

The Regular Meeting of the Mayor and Council, of the Borough of Atlantic Highlands, was held on June 22, 2005 in the public meeting room of Borough Hall, 100 First Avenue, Atlantic Highlands, and NJ.

Mayor Donoghue called the meeting to order at 7:30 PM. After a silent prayer and the Pledge of Allegiance, the following roll call was taken: Council members Archibald, Nolan, Noonan, and Spatola. Temporary Administrator Jahn, Borough Attorney Miller, Borough Engineer Elliott, and Municipal Clerk Harris were also present. Council members Fligor and Ladiana were absent.

Mr. Harris stated that notice of this meeting has been transmitted to the Asbury Park Press and the Courier, continuously posted in the Borough Hall on a bulletin board reserved for such announcements, and filed with the Municipal Clerk of Atlantic Highlands, on 1/5/2005. He read the "Open Public Meetings Act" compliance statement and stated that formal action would be taken.

Mayor Donoghue mentioned that the Fireman's Fair start on June 29^{th} and runs through the July 3^{rd} . The fireworks will be on July 2^{nd} .

PUBLIC COMMENT SESSION

Edward Cetron-1 Auditorium Dr-mentioned that they are having problems with trees in the Borough, and the enforcement of not tearing them down. One of his neighbors took a massive tree down without properly securing the tree, almost taking out the power poles. The Police were reluctant to go and rectify the situation. Another neighbor went and got permits to trim trees that were on his (Mr. Cetron's) property. He would like the Borough to make a statement to go back and start re-enforcing the steep slope permits and the shade tree permits. He suggested a mailing or a new resident packet informing them of what the Ordinances are.

Capt. Amici-AHPD-commented that if the Police get a complaint they respond. The Police always ask if they have a permit. If they do fine, if not they have them stop working and come down and to Borough Hall and get a permit. Whenever they get a complaint, they act on it.

Council member Archibald suggested that the chairman of the Shade Tree Commission sit down with the Code Enforcement Officer and the Chief of Police so they are all on the same page and have the right dialogue going.

Mike Rybeck-North Ave- asked if the smoke testing is complete at this time and if those residents found in violation have been contacted yet. He also questioned the DOT being connected to our sewer lines via one of the boxes on First Ave.

REPORTS - COUNCIL MEMBER, COMMITTEE, PROFESSIONAL

Mayor Donoghue commented that the Bayshore Regional Strategic Plan study would be meeting at Borough Hall on Wednesday June 29^{th.} This is primarily dealing with environment, park and open space issues being discussed by the Bayshore Regional Strategic Plan committee. There will be a meeting following that, which will deal primarily with Atlantic Highlands.

Council member Spatola reported on the Fourth of July Fireworks being held on July 2nd at 9:30. The brochure will be sent out to residents tomorrow, entailing the whole five days activities. On Thursday the Fireworks Committee had a fundraising Cocktail Party that went well.

Council member Archibald reported that he had followed up with the DOT and Assemblyman Corodemus' office regarding the proposed bike lane on Memorial Parkway. The DOT will not be going forward with the bike lane until they meet and consult with the Borough. They meeting is scheduled for July 6th with himself, the Mayor and the Administrator, at which time the DOT will present their plans regarding the proposed bike lane. He will make those plans available for the Council's review.

Council member Nolan reported that the drainage study on the Fireman's field, that was started back in November has been completed, and we have finally received the report. It outlines some of the issues and offers recommendations. He will give any one that desires a copy of the report.

Council member Noonan reported that Administrator Jahn had informed him that he had been thorough in researching people about gutters and leaders on the Borough Hall. Once these are installed they will reduce some of the leakage into the building and alleviate some of our difficulties.

Administrator Jahn recommended that the Council consider approving bills on a twice a month basis instead of monthly. This would decrease vendor inquiries into the office and decrease the workload on the staff.

Engineer Elliott reported the Route 36 and 7th Ave inlet is currently under construction.

Council member Nolan asked if the bids were going out on the tennis court resurfacing. The funds needed to be certified as available, prior to that. Councilmember Archibald feels that the costs should come out of the Harbor budget. We would be able to use the Borough's funds on other parks and the Harbor could take it out of their existing revenue. He feels this should be investigated.

PUBLIC COMMENT SESSION

Mickey Rast- 49 Eight Ave- commented on the magazine titled The Captain's Guide. Atlantic Highlands was advertised in the magazine. It will be distributed along the eastern seaboard from Maryland to New York. It was funded by a joint venture between the Chamber of Commerce and the Harbor Commission. She also displayed a copy for the council to see.

Jane Frotton-Harbor Commission-feels Council member Archibald's comments regarding the tennis court resurfacing, was a great idea. It has always the been the responsibility to resurface the tennis courts and put up new fencing out of Harbor funds, as was the construction of the new basketball courts. The have always tried to keep that recreation going with Harbor funds so it would not affect the tax dollar.

William Eaton-asked if the plans for the bike lane on Memorial Pkwy would be available prior to the meeting on the 6th. He asked if it would be possible to have them available at Borough Hall.
