## MINUTES OF THE MAYOR & COUNCIL REGULAR MEETING OF JULY 26, 2006

The Regular Meeting of the Mayor and Council, of the Borough of Atlantic Highlands, was held on July 26, 2006 in the public meeting room of Borough Hall, 100 First Avenue Atlantic Highlands NJ.

Mayor Donoghue called the meeting to order at 7:30 PM. After a silent prayer and the Pledge of Allegiance, the following roll call was taken: Council members Archibald, Doyle, Fligor, Ladiana, Nolan, and Spatola. Administrator Hubeny, Borough Attorney Reilly, Borough Engineer Robert Bucco, and Municipal Clerk Harris were also present.

Mr. Harris stated that notice of this meeting has been transmitted to the Asbury Park Press and the Courier, continuously posted in the Borough Hall on a bulletin board reserved for such announcements, and filed with the Municipal Clerk of Atlantic Highlands, on 1/04/2006. He read the "Open Public Meetings Act" compliance statement and stated that formal action would be taken.

#### APPROVAL OF MINUTES

## REPORTS - COUNCIL MEMBER, COMMITTEE, PROFESSIONAL

Council member Archibald reported that he would touch on the Conifer situation in Executive Session. He further reported the Environmental Commission met last Thursday evening and it was more of routine business than anything else. No breaking news to report from there.

Administrator Hubeny reported that the new SUV for the police Dept was in. It was bought on State contract for around \$23, 000.00 and will be the only vehicle they will get this year. It still needs to be outfitted with lights and things.

Council member Spatola reported that Tuesday August 15<sup>th</sup> will be the third annual Mark Spatola Memorial Blood Drive. It will be at the Senior Center down in the harbor.

Council member Doyle reported that the Harbor Lease Committee met and they are reviewing the fees for next year. We should have a resolution by the next Council meeting.

Council member Archibald asked that if the leases could be sent out on a timely basis t prevent the situation that occurred last year.

Harbor Commissioner Frotton commented that they would be going out on September 1st, with December 1st being the due by date.

Council member Nolan had no report.

Council member Fligor reported that he 5<sup>th</sup> annual Genevieve M. Hawley Memorial Foundation brunch is August 13<sup>th</sup> at 12:00pm. The cost is \$30.00 per person and the proceeds are used to send recipients to college. He also mentioned that he spoke to the Sewerage Authority about renting from the Borough the facility on the nights that they have meetings. It costs us as a Borough for lighting, paper the use of machines and although it is not a done deal, he has asked them to talk with the administrator and maybe we can reach an agreement. He further reported that although flows are down, they are still above the previous years. This past month we are at 1.25 million, which represents 49.8 percent of the total combined flow. He reported NJNG is working on the Borough yard and will be for the next 18 months. They will be working on residential property in the Highland Ave, South Ave and Ave B area along with the Sodon property. There are a lot of things going on in the background and it may at times appear as if nothing is happening but a lot is going on. We have a new site manager at DEP, he called her and left a message introducing himself and she will be attending the public meeting at the field house on August 30.

Council member Ladiana reported she would be attending the Green Acres Round Table seminar on August 1<sup>st</sup> and the Brown Fields Remediation seminar on the 28<sup>th</sup>. She commented that she was happy to hear the roads program issues had been worked out except the cost issues. The Buildings and Grounds Committee will be meeting on August 1<sup>st</sup> with the Library Committee to discuss possible additions.

Administrator Hubeny reported the Street Dept would be out picking up brush. There are timelines and guides that we have to manage with storm water management rules, and we are trying to clean up the streets. We are trying to educate the residents in putting out the brush and twigs and things like that. We do not pick up grass. clippings. Come the fall if people are in violation they will receive a summons. He has received a lot of complaints about 120 Grand Ave. We are hoping by Friday that the problem will be rectified. If need be we would cut the grass and put a lean on the property. He reported the highway signs on First Ave and 36 are faded and you can't read them. He had contacted the State and they will not be replacing them any time soon. There is a program, but it is a funding issue. He reported that the Streetscape pavers are done. The lights are on order. There was some debate on 12' or 14' poles. The taller poles would hit the wires. He commented on a letter he received from a Bayside Drive resident who started to put steps down onto Bayside Drive. The Building Dept put a stop to the work and he now wants to apply to the zoning for a permit because part of the structure would be on Borough property. Part of that wall was designed as mediation to prevent that house from coming down. He sent a letter to Mr. Bucco and the consensus is the only way the zoning officer would approve it would be by approval by the Mayor and Council because it is on Borough property. He further reported that the Borough saved over \$15, 000.00 on the refinance of 1996 bonds. He got an estimate from Mr. Bucco for his administrative fees on the 2006 road projects but would like the mayor and Council to authorize Mr. Bucco to proceed on the design of this. If we do not move now we will be doing 2006 projects in 2007.

Council member Nolan made a motion authorizing the Borough Engineer to begin the design work on the 2006 Road project. It was seconded by Council member Ladiana and was approved by the following roll call vote:

M. Hubeny reported that the DEP visited us unexpectedly and reported on our water quality, which was perfect. He noted we still have about 200 water meters that need replacing. We are adjusting bills and have a bout 40 written complaints and are getting through them slowly.

He finally reported that the drains and sump pumps at the Harborview Towers have been tested and all but one has been found to be in violation and it is being taken care of.

Engineer Bucco reported that the NJDOT application has been submitted for Streetscape Phase III. He also mentioned that he spoke with the County regarding Bayside Drive. The County is proposing a 56/44% split from Ocean Blvd to the outfall, for the repair work and future maintenance done on Bayside Drive, which would carry out in perpetuity. The original plan was 25% County and 75% to the Borough. The County would absorb all soft costs for the project. The County would be paying about \$112,000 plus the \$75,000-\$80,000 in soft costs, and the Borough would be paying in general about \$88,000.00.

#### PUBLIC COMMENT SESSION

Mike Harmon-33 Bonnie Brae Path- commented that he was at the planning board in Middletown and from his perspective, we went through an elaborate planning phase with Conifer back in 2002 and we have all heard about this famous sketch 5, it is very discourage in Middletown does not have it. The Borough clerk in Middletown says that they are not able to ask Mr. Carton for his work product. Birdsall says they might have it but won't release it unless they have Conifers permission. Middletown and Atlantic Highlands are supposed to be partners in this endeavor. What has happened here is Middletown and Conifer have been making side deals since some point when I was Mayor and some point afterwards. I was faulting this Council, and I apologize, because they were doing things that you would have no way of knowing. [He gave the Council members drawings and documents for their review]. He also commented that Larry Carton stood before the planning board in Middletown and made a speech that was completely full of inaccurate statements. He [Mr. Harmon] stood up and was told to sit down, shut up and wait his turn. What happened after that was unbelievable. He was not allowed to ask the engineer any questions. Members from the public, from Atlantic Highlands, were not allowed to ask any questions. Carton is the lawyer that put this all together for Middletown. It [sketch 5] is part of the agreement that we signed. \$3,000,000 dollars have changed hands. Conifer has made a substantial profit and now they won't produce sketch five. That is not friendship. That is not cooperation and it is not just.

### UNFINISHED BUSINESS

# RESOLUTION APPROVING EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-48 BOROUGH OF ATLANTIC HIGHLANDS MONMOUTH COUNTY, NEW JERSEY

WHEREAS, an emergency has arisen with regard to unanticipated and unusually substantial legal and planning costs being required and incurred in order to comply with various mandates and directives by the State Council on Affordable Housing (COAH) for certification of the Borough's Third Round Affordable Housing Plan and to address comments or objections to that Plan, and it is an obligation of the Borough to complete that Certification in order to address State requirements as to housing availability in the public interest and welfare, and

WHEREAS, provision in the 2006 Budget to address this COAH legal and planning requirements and costs was not adequate due to its unanticipated requirements and amount of legal and planning work required to comply, and N.J.S.A. 40A:4-46 provides for the creation and authorization of an emergency appropriation for that emergency purpose, and

WHEREAS, the total amount of the emergency appropriations created, including this appropriation authorized by this Resolution, is \$80,000, and three percent (3%) of the total operating appropriations in the 2006 Budget is \$111,754.20 and this Emergency Appropriation is thus pursuant to N.J.S.A. 40A:4-48, and

**WHEREAS,** the Borough Governing Body has determined that an emergency exists to meet and address these COAH requirements and obligations requiring a supplementary appropriation.

**NOW THEREFORE BE IT RESOLVED** by the Borough Council of Atlantic Highlands, Monmouth County, New Jersey (two thirds of the Council members affirmatively concurring) that in accord with N.J.S.A. 40A:4-46 to 48:

- 1. An emergency is declared requiring funding for unanticipated legal and planning costs for COAH compliance and certifications and an Emergency Appropriations is hereby made for such costs/expenses in the amount of \$80,000.
- 2. That said emergency appropriations shall be provided in full in the 2007 Municipal Budget, and is requested to be excluded from CAPS pursuant to N.J.S.A. 40A:4-45.3.c(1).
- 3. That the Acting Chief Financial Officer has certified that the expenditures to be financed are related to the aforesaid emergency.
- 4. That two certified copies of this Resolution be filed with the State Director of Local Government Services.

## CERTIFICATION OF FUNDS

This is to certify that the expenditures to be financed through the \$80,000 Emergency Appropriation scheduled to be adopted on July 26, 2006 will be related and utilized for the payment of legal and planning services and work required as a result of various directives and mandates required to meet COAH requirements for certification of the Borough's Third Round Affordable Housing Plan.
