## **RESOLUTION 066-2006**

# AUTHORIZING THE APPEAL OF THE COAH DECISION RESTRAINING THE BOROUGH FROM TAKING CERTAIN ACTION ON THE McCONNELL TRACT

WHEREAS, on January 19, 2006, the Council on Affordable Housing heard a motion of K. Hovnanian who sought emergent relief restraining the Borough of Atlantic Highlands from condemning or taking further steps towards the condemnation of property known as the McConnell tract and further restraining the Borough from granting any development approvals on property within the Borough; and,

WHEREAS, after hearing the matter COAH voted to grant the motion in part and restrain the Borough from condemning, purchasing or taking any irreversible steps towards condemnation of the McConnell tract and further ordered that neither party take any adverse action with regard to the application currently pending before the Atlantic Highland's Planning Board; and,

WHEREAS, the Borough must have representation by an attorney who is an expert in the field of affordable housing law to appeal this decision by COAH; and,

WHEREAS, Jeffrey R. Surenian, Esquire, has distinguished himself academically and in practice in the affordable housing arena since 1984, and has already been working to represent the Borough of Atlantic Highlands against K. Hovnanian Shore Acquisitions, LLC; and,
