MINUTES OF THE MAYOR & COUNCIL REGULAR MEETING OF JANUARY 24, 2007

The Regular Meeting of the Mayor and Council, of the Borough of Atlantic Highlands, was held on January 24, 2007 in the public meeting room of Borough Hall, 100 First Avenue Atlantic Highlands NJ.

Mayor Donoghue called the meeting to order at 7:30 PM. After a silent prayer and the Pledge of Allegiance, the following roll call was taken: Council members Archibald, Delloso, Doyle, Rigor, Spatola and Sutton. Administrator Hubeny, Borough Attorney Reilly, and Municipal Clerk Harris were also present.

Mr. Harris stated that notice of this meeting has been transmitted to the Asbury Park Press and the Courier, continuously posted in the Borough Hall on a bulletin board reserved for such announcements, and filed with the Municipal Clerk of Atlantic Highlands, on 110212007. He read the "Open Public Meetings Act" compliance statement and stated that formal action would betaken-

Mayor Donoghue presented a proclamation. to the family of Donald Brown II:

For His Achievements in Football and The Pride He Has hurilled in Borough and Area residents

WHEREAS, Donald Brown II, a University of Connecticut football player, borough resident and graduate of Red Bank Catholic High School, has earned a place on the 2006 All-Big East football all-star second team; and,

WHEREAS, Donald Brown is the first freshman in UConn history to make the All-East second team, which is chosen by league coaches, and is the only freshman player to make the 2006 All-East second team', and,

WHEREAS, Donald Brown, a UConn running back, averaged 134.6 yards ;game during the 2006 season, eclipsing 100 yards per game three times and 200 yards twice: and,

WHEREAS, Donald *Brown* caused considerable consternation among players *for* and *fans* of *Rutgers*, the New *Jersey State* University, on Oct. 29, 2006, when he ran for 199 yards against the then 12th-ranked Scarlet Knights in his first UConn start.

THEREFORE, because of Donald Brown's accomplishments, the Mayor and Council deems it appropriate to acknowledge these achievements, which have instilled a great sense of pride in this community, and to offer him continuing encouragement, both athletically and academically.

NOW, THEREFORE, BE IT PROCLAIMED by the Mayor of the Borough of Atlantic Highlands that Donald Brown II he and is hereby recognized and praised for his efforts and that the people of the borough are urged to take note and celebrate his outstanding performances.

WHEREAS after serving his country in North Africa, France and the European Campaign, and rising to the rank of Colonel, he returned to Atlantic Highlands and with his cousin opened Aday's Sportsmen Shop in 1948.

WHEREAS. for 59 years Jerry Greenberg and Arjay's have long been a cornerstone and landmark. Jerry has time and time again shown his love, commitment and dedication for his community, and it is now fitting that Atlantic Highlands show its regard for him.

APPROVAL OF MINUTES

Regular Meeting – January 01, 2007

This motion was offered and moved for passage by Council member Archibald and seconded by Council member Fligor.

This motion passed by the following vote,

Mayor Donoghue appointed a committee to study and make recommendations as to the best way to provide a new public Library. He appointed Roy Dellosso as Chair, Municipal Clerk, Dwayne Harris, former Council member Stephanie Ladiana and Library Board member, Debbie Traphagen. He charged them to evaluate all of the possible locations for a new library and the economic impact it would have. He asked to have their report no later than three months from now, if possible.

REPORTS - COUNCIL MEMBER, COMMIT I EE, PROFESSIONAL

Council member Dellosso had no report.

Council member Sutton read a memo from Richard Ambrosio of the State DEP had conducted a Compliance Evaluation Inspection and congratulates all members of the Water and Sewer Dept for keeping the 1941 water plant up to code and in compliance with State mandates.

Council member Fligor reported that the Police Interrogation room is almost complete. They also received a \$3,800.00 speed sensor radar display system, located on Grand Ave. It is a pole-mounted sign used to record data and help control problem areas. The Police in 2006 conducted 1691 traffic stops, 1228 summons issued. There were 170 adult and 59 juvenile Uniformed Crime Report arrests, ranging from robbery to mischief Patrolman Richard Glietz and Detective Tom Stone received a letter of thanks from the NJ State Police for their assistance in the case regarding Wayne Smith. He also reported that Sewerage authority plants are going to get an upgrade to their controls, allowing the plant to operate safely and automate the system. The Sewerage Authority is hosting a safety meeting sponsored by the JIF here at Borough Hall. Each member that attends, the Borough will receive a \$250.00 credit towards the JIF bill. The Authority is still holding back TOMSA payments because of some questionable billings. NJNG will be having a public meeting in February and a flier will be sent to everyone in the town. The meeting will cover the overall project and the project beginning on South Ave. He encouraged all residents to come and gather the information. The South Ave Park will be fenced off and closed during the project. NJNG will access this area from Highland Ave only and will not be on

South Ave.

Council member Archibald reported that the Environmental Commission has not met this year due to the illness of Chairman Boyd. The recreation Committee met and Karen Moses is the new Chairperson. They thanked Zena Kammers for her one-year as Chair. Basketball started at the school on January 13 and will continue every Saturday through March. He reviewed some of the other planned events sponsored by recreation. He mentioned that Summer Recreation begins July 9 and will run thru August 17 for ages 5-12. Applications for counselors will be accepted beginning in May, until June 2 and can be gotten at Borough Hall. He thanked Tommy Murray for running the summer band conceit for the last ten years, and would like to see him recognized for all of his hard work. Other events are being discussed and some do not have firm dates. They are also discussing an "Outdoor Movie Night" at some point in the Borough.

Council member Spatola reported that she met with Mike Harmon to discuss the proposed soccer fields. She has not had the opportunity to speak to others that had met with Mike; she feels they may be some fuzzy issues. She would rather not give specific details until she has had an opportunity to confer with the other members. She reported that she and Council member Fligor stopped in to court to observe James Butler, the new prosecutor. He was moving things in and out rather efficiently..

Council member Doyle has only one issue for executive session.

Administrator Hubeny reported that the Borough received the \$125,000 from the escrow account this afternoon. Those monies will be put into a dedicated trust, to be utilized for the soccer fields. He reported that Bayside Drive would be opened on Friday. A hand delivered letter will notify our residents. Highlands will be closing their side. The Borough received a check in the amount of \$18,296.30, which is equal to 2% of the basic

revenue. We still do not have a signed agreement with Comcast. He also reported that we received a check for \$10,110.00 from NJNG. This is reimbursement of costs incurred to install the new salt shed. He reported the Borough newsletter would be going out in the next four weeks. There will be news in there about the Hazlet swim club deal. He had sent a memo to everyone on the suggested closing of Sears Landing. He and Dale Lubner had gone and looked at the road. The town had spent money to improve the drainage, the road is in desperate need of repair and the engineer feels that it is a safety issue. He requested permission to inform the residents of the road closure for safety issues. He reviewed the resolutions being considered for the evening.

PUBLIC COMMENT SESSION

Mary Wall — 79 Ocean Blvd she asked Council member Fligor if the commissioners on the Sewerage Authority received health benefits.

Jackie Jones- Keystone Drive asked what it meant to vacate a street. She commented on the appointments remarking that her personal feelings are that there is too much competition between towns for grant monies and dollars from whatever sources and there are a tot of conflicts that could be created in sharing professionals. It makes her concerned about people who have been appointed to make decisions and recommendations for things that need to happen in this town and are making recommendations for towns that re on our borders.

Mike Harmon — 33 Bonnie Brae thanked Council members Fligor, Sutton and Dellosso for listening to him. He still feels that it is important to have a soccer field in town and a sledding hill. Regarding Mrs. Spatola comments, he does agree we could run a field north and south [on Center Ave] but the Borough does not own the land. He was mistaken in his GIS plan showing a full size field at Conifer, when the original plans did call for a junior field. The field could fit in the space [Center Ave], but it would overlap the Hobie Cat parking and would go into he woods, but it could be configured. He also commented on some other issues regarding Green Acres and the Statehouse Commission, the releasing of the funds after a two-year period and the construction timetable. He feels the Borough should have a fair estimate as to what that field is going to cost

William Phillips — Memorial Pkwy, asked about the status on the Palmar Constructio suit.

UNFINISHED BUSINESS

Mayor Donoghue commented that as promised, he is naming his choices for professional appointments at this time. They are Ronald H. Gordon, a Marlboro resident, for Borough Attorney, Katherine Elliott of Birdsall Associates for Borough Engineer and William Meyler, of Middletown, for Municipal Auditor. These individuals are highly qualified for these positions and offer the best chance of saving taxpayers money and would eliminate real or potential conflicts of interest or the perception of conflicts. On January 1' and again on the tenths, I deferred my nomination for these positions, because I was not convinced that all members of the council had fully considered the applicants who submitted bids under our new an fair open policy... I am still not sure there has been adequate consideration but he is pleased that three Council members, including the Council President were involved in at least some of the interviews he conducted. Although the 2006 professional continued their appointments after New Years Day, he feels it is important to remove the uncertainty of who will fill these positions in 2007.

RESOLUTION 030-2007, APPOINTMENT OF MUNICIPAL ATTORNEY

This resolution was offered and moved for adoption by Council member Dellosso it was seconded by Council member Sutton.

Council member Archibald commented that he was still disturbed by the Mayor actions at the last meeting, were he would not allow the majority to put an item back on the agenda and allow us to vote on it. He still thinks it is a serious issue what he did to this council and he really violated any mist or goodwill he may have had with the republican majority. He also asked the Mayor to provide the projections that would substantiate the proposed savings. He felt the Mayor was giving Mr. Gordon a blank check every time a Council member picked up the phone to call. He then asked who would be auditing the bills every time they picked up the phone to call.

Mayor Donoghue commented that we need to have trust in the honesty of the attorney. He is confident that Mr. Reilly is not charging us for services he did not provide, the former attorney did not and there is no reason to believe Mr. Gordon would.

Council member Dellosso commented that based on what we paid Mr. Reilly last year, it would take 400 hours of work to break even. If you divided that over 12 months and took out the two or three hours a month for meetings, it would still require an additional 75-80 hours of work that would need to be done. He believes that the Borough would not use all of that time.

Council member Spatola commented that she was uncomfortable at loosing the retainer. The retainer is in place to put a cap on the attorney's bills. Originally Mr. Gordon requested a \$40,000 retainer, and she feels he may be a little up there in price. She would be comfortable knowing a phone call is covered under a retainer, so she wouldn't have to watch the clock to make sure she is not talking over five-minutes.

Council member Doyle commented that he feels the Mayor did not take this whole process seriously from day one. We received RFPs on December 18 " and was announced that you would make appointments on January 1". If he had inklings that he could not make the January I", he should have mentioned it when we received RFPs. He was still conducting interviews a late as last week. We are talking about money. Mrs. Miller cost the Borough in 2004, \$77,00.00 with no experience; in 2005, after a year's experience, \$80,000.00. Mr. Reilly cost us \$51,000.00. Those are pretty good savings right there.

After continued Dialogue this resolution was defeated by the following vote.

NAYS: Council member Archibald, Doyle, Fligor and Spatola

Council member Archibald made a motion to name Bernard Reilly as Borough Attorney. Mr. Reilly has been a lawyer for over 30 years. He has done outstanding work for our Borough for at least the last ten to fifteen years and has argued cases on behalf of our *Borough*, before the NJ Supreme Court, which he has won. Council member Fligor seconded the motion.

Mayor Donoghue commented that he doubts that there was any serous consideration to any other candidate and he finds that disappointing.

This resolution was adopted by the following vote.

AYES: Council members Archibald, Doyle, Fligor and Spatola

NAYS: Council members Delloso and Sutton

RESOLUTION 031-2007, APPOINTMENT OF MUNICIPAL ENGINEER

Mayor Donoghue had previously offered the name of Katherine Elliott of Birdsall Engineering

This resolution was offered and moved for adoption by Council member Dellosso seconded by Council member Sutton.

Council member Fligor commented that Birdsall is the Engineer for Conifer and that is a conflict. There was damage to our Lenape Woods. He had sent a letter that *they* needed to be fixed and has not been fixed to date.

Council member Sutton asked if the contractor came on his own to do the work at Lenape woods and ascertained that the contractor was afraid they would not get permission and preceded without the knowledge of Birdsall or LGA, the firm hire by Conifer.

Council member Doyle commented that Kathy Elliott was the engineer that approved the construction of the house on Lawrie Road. She supported the plans that put development on Keystone Drive and she does not feel she is attuned to the sensitivity of steep slope. She also served as the supervisor on Streetscape phase I and we recall the issues that developed. He is not comfortable having Ms. Elliott back.

Council member Archibald commented the under one year with Mr. Bucco we got \$600,000-700,000 in grants and Ms. Elliott, in two years got us close to maybe a \$100,000, so it is pretty clear our current engineer is doing a great job for the Borough.

Council member Doyle commented that the concerns having professionals working for two towns, whether we like it or not, is the rhetoric coming out of Trenton and I think we want to stay an independent entity and we can show Trenton that we are working to keep costs down between towns, and if there is a conflict, they would step down and we can pick up with another engineer.

After continued dialogue the resolution was defeated by the following vote.

AYES: Council members Delloso

NAYS: Council member Archibald, Doyle, Fligor, Spatola and Sutton

Council member Doyle made a motion to name Robert Bucco as Borough Engineer.

Council member Sutton commented that he knew Mr. Bucco when he worked for Schoor Depalma and he felt he did an excellent job at the time. He had spoken with Council member Archibald regarding the concems he has with the conflict he has serving different agencies simultaneously. He feels Mr. Bucco is a professional and he does not feel appointing Mr. Bucco the Engineer would hurt the town.

Council member Archibald seconded the motion.

Council member Fligor commented that he had observed Mr. Bucco work between the Sewer Authority, TOMSA, Highlands and Middletown, he is very professional. In all of those instances Atlantic Highlands has always come out on top.

Council member Doyle further remarked that he had met with Mr. Bucco and he is comfortable with his relationship with Middletown, and he is doing good work for our town. If there is an issue between the towns, we will expect his expertise to tell us there is an issue and then we will figure out what to due.

The resolution was adopted by the following vote.

RESOLUTION 032-2007, APPOINTMENT OF MUNICIPAL AUDITOR

Mayor Donoghue had previously offered the name of William J. Meyler.

This resolution was offered and moved for adoption by Council member Sutton seconded by Council member Dellosso.

Council member Spatola commented that the tinting is very wrong to engage in a new auditing firm. As we only have a part time CFO working and as the mayor commented, "our books are in a considerable mess", she would feel more comfortable having an auditor who has 25 years experience and is familiar with our Borough. Your candidate has less and experience and does not specialize in municipal audits. Yes, he is cheaper, but she does not want another professional "cutting their teeth" on this town and cannot support his candidate.

Mayor Donoghue commented that he thinks it was actually Mr. Farrell that made the comment and that she intended to gloss over the savings that could be realized. He respects her view but she is understating Mr. Meyler's qualifications; he is the auditor for three municipal entities at this time. He has been in this business for 10 years and he proposes to perform the services we require for \$16,000 less.

Council member Archibald mentioned that Mr. Meyler was no longer the auditor in those three municipalities and he had some concerns with the way he manages his own business.

Council member Dellosso commented that he had spoken with Mr. Farrell to ascertain the severity of the condition of the Borough books and what would be required to fix them. Mr. Farrell had no definitive answers. He [Dellosso] walked out very unimpressed that he could not give us the direction or new what to due to correct what our situation was. He said, "We are a mess" and left it at that.

Council member Archibald commented that Mr. Farrell has given an action plan to the CFO as to what needs to be done to correct the problems.

After continued dialogue the resolution was defeated by the following vote.

Council member Spatola made a motion to name Eugene Farrell as Municipal Auditor. Council member Archibald seconded the motion.

FINAL ADOPTION was moved by Council member Sutton, seconded by Council member Spatola and approved by the following vote.

Mayor Donoghue appointed the following individuals to Class IV positions on the Planning Board to fill vacancies: John P. Lollos for the unexpired term ending on 1213112007 and Suzanne Caffrey and Richard Marcolus for the unexpired terms ending 12!3112008.

Council member Doyle asked the Mayor to reconsider and put Mr. Frotton or Mr. Dean on the board. They have the qualifications to remain there and now is not the time, due to sensitive issues before the board, to bring in rookies. He questioned the Mayor on his desire to pick the best for the Borough, and here are two qualified individuals, volunteering their time and you [Mayor] will not consider them.

Mayor Donoghue commented that they were duly considered, and does not think it necessarily his responsibility to follow the recommendations of the Republican Party. These two people are highly intelligent businessmen, one is a lawyer and he has no questions about them whatsoever.

Council member Doyle applauded the individual volunteers but commented that since *you* have been Mayor, you have not appointed a Republican to the Planning Board. In your State of the Borough address you wanted more bi-partisanship... yet you now have a Planning Board with Democrats that you have appointed. Your actions seem contradictory and needs some clarification.

Mayor Donoghue commented that he feels it his job to appoint the people he feels are best qualified. He does not know the political affiliation of several of the people that he has appointed, nor does he care. All he knows is that they are interested citizens of considerable intelligence and will do a good job.

Council member Archibald asked the Mayor how could Mr. Lollos be more qualified then Mr. Frotton, who was the former zoning officer.

Mayor Donoghue commented that it is time to give other people a chance. These people have been rotating in these various jobs for many years. This gives an opportunity to a citizen who volunteered, within the deadline that I stated back in December.

Council member Spatola commented that the Mayor obviously overlooked Mr. Frotton because he is over-qualified. Being the Borough code enforcement officer and the zoning officer gives him way to much experience to serve on our Planning Board.

PUBLIC COMMENT SESSION

Jane Frotton — I2 Memorial Pkwy, thanked Council member Sutton and Dellosso on how they conducted themselves tonight as opposed to others at a previous time. Mike Rybeck — North Ave, extended an invitation to council members Sutton and Dellosso to come and see the workings of the sewer plant.

Mary Wall- Ocean Blvd, asked if there would be any business after executive session

William Eaton — Bay Ave, commented that he advocated Mr. Bucco because he is a firm believer that regional knowledge and regional understanding is a plus. He liked Mr. Hoder because of his price. He really thinks T&M is a very capable, qualified, regionally minded engineer firm, and he thinks it is important for us to understand as a community, that there are regional issues, and the collective memory of people who have worked here for a period of time, we benefit from that knowledge.

Council member Archibald commented that he feels that things would be a lot more productive if he would consult with the Republican majority before he forms committees. This Library Committee is something new, the fifth committee that you formed without reaching out and talking to us to see of we buy into it He also wanted to know if the Mayor and Council would be getting timely updates and if the report would be a written report.
