

MINUTES OF THE MAYOR & COUNCIL REGULAR MEETING OF MAY 28, 2008

The Regular Meeting of the Mayor and Council, of the Borough of Atlantic Highlands, was held on May28, 2008 in the public meeting room of Borough Hall, 100 First Avenue Atlantic Highlands NJ.

Mayor Rast called the meeting to order at 7:00 PM. After a silent prayer and the Pledge of Allegiance, the following roll call was taken: Council members Archibald, Delloso, Doyle, Fligor, Hoffmann and Sutton. Administrator Hubeny, Borough Attorney Reilly, David marks of T&M Associates was representing Borough Engineer Robert Bucco, and Municipal Clerk Harris were also present.

Mr. Harris stated that notice of this meeting has been transmitted to the Asbury Park Press and the Courier, continuously posted in the Borough Hall on a bulletin board reserved for such announcements, and filed with the Municipal Clerk of Atlantic Highlands, on 1/02/2008. He read the "Open Public Meetings Act" compliance statement and stated that formal action would be taken.

REPORTS - COUNCIL MEMBER, COMMITTEE, PROFESSIONAL

Council member Dellosso had no report.

Council member Sutton reported that the was a leakage problem at the Observatory Place storage tank. There are still working on a the resolve and the water is temporarily diverted to a storm drain. T&M is still working on the water plant's filter evaluation and rehabilitation project. The design is still being drafted to specifications. The Water main Replacement Project – Avenue C is done with some minor road repair left to do. Second Ave will start next week and Sixth Ave will be done after that. He reported on the flows for the month of April being 48.2% which is consistent with the last two months.

Council member Fligor reported that a petition was out front asking FEMA to delay the implementation of the new flood maps. They will be forwarded to Assemblywoman Handlin who is sponsoring the petition drive. He reported that the Mayor of Highlands would like the

Borough to share any maps that we may have regarding Bayside Drive. Highlands desires to work with the Borough to get the street open. He reported that the PBA raised \$12,000.00 at their Annual Ball. That money is being donated to the food pantry. The PBA also honored former Chief Samuel Guzzi, with a gold State PBA card, for the work he has done. He also reported on the new dispatcher and police officer who are in training. He mentioned that one of the vehicles was involved in an accident that resulted in about \$4,000 dollars in damage, and no one was injured. He reported on the overtime for the month and the efforts of the Chief, Captain and Lieutenant to alleviate that. There is a tentative public meeting on June 17 from 5-10pm with NJNG, at the Fireman's Field house. He conferred with Attorney reilly on the completion of Leonard Ave. Attorney Reilly commented that there are still outstanding issues on their [NJNG] end. He reported that the will be a meeting between the Borough, NJNG and the DEP on June 25, 2008 at 10:30am. They have asked for congressman Pallone and Senator Kean to be there. This is an effort to speed up the work that is being done, which looks like it at a standstill. He reported that NJNG will test at the Casrielle property at night for the next four weeks.

Council member Doyle commented that the budget will be introduced this evening. He also congratulated Bernie Frotton on the success of the Memorial Day Parade.

Council Member Hoffmann reported on the boat launching in the Harbor. The boats still in the parking lot, at the end of this month, will pay rental fees. There is work going on in the dredge pit. He commented that the Harbor is buzzing with activity and hopefully this will be a good season. He finally reported on the Fireman's Fair with the last night being "Concert Night" feature live bands.

Council member Archibald commented on Summer Recreation which will begin on July 7th and run for six weeks and the sign ups are going on now. There will also be Lacrosse, tennis and field Hockey camps being run also. He commented on the success of the garage sale and thanked the staff at Borough Hall for all of the work they do during the week.

Administrator Hubeny gave updates on the progress of the skate park, moving forward with contracts on that and the upgrades with the pro series. At the soccer field they have the top soil stripped, the block wall is up, the conduit is in the ground and moving along very well. The Road Project has East Ave done except final pavement. On Ave C we've done some change orders regarding curbing, that will be before you next month. The curbing is complete up at Lenape Woods and E. Highland Ave and they are now moving to Hillside Road. We have a lot of things going on in town and the engineers are on top of it. He reported we had bid openings today for the Bayshore Trail and Wagner's Creek. Those bids came in below the engineers estimates. He asked them to take a look at the engineering proposal for the Bayshore trail and Wagner's creek, which he had sent by e-mail. He reported the Street State III application is being completed by Birdsall and is being submitted on the State's SAGE system. He reported that there is a youth Comission Car Wash in the Harbor. The commission was told that they would not be permitted to have that type of fundraiser next year, because of the storm water management policies.

Attorney Reilly commented on the Tax Abatement Ordinance. The Borough will need to amend the current Ordinance by changing the amount. He also commented on the Harbor restaurants and a hearing is being slatted for next Wednesday, in Freehold.

Dave Marks of T&M reported the plan design for the 7th Ave under drain project should be completed and ready for advertising for bidding on July 23rd. We could award at the August 13 meeting. If we can advance these times frames he will get it done. He reported that he looked at the construction cost estimates for the Borough Hall HVAC. After conferring with Paul Sweetwood, he really could not tighten up the estimate prior to any kind of work being done. He was also asked to look at infiltration into this building. After conferring with Mr. Hubeny, public works is going to dig a test pit so they can come and observe that so they can get more information as to what is going on outside of the building. He commented on the situation with Conifer and asked the Borough to proceed with the preparation of the Soil Conservation Permit application so they can move forward with the removal of all that concrete debris and material.

Chief Vasto reported that his new officers and dispatcher are on track with their training.

PUBLIC COMMENT SESSION

Jane Frotton – 12 Memorial Pkwy commented that the Harbor will be movie forward with a "Dunkin Donut" style punch card where boat launchers would receive punches and on the seventh or eighth punch, there launch would be free.

Joseph Hawley – 25 Ocean Blvd commented on the Beautification committee is meeting on Monday and asked if the administrator could attend their meeting to provide guidance to them on the Mayor's Ball and how they can establish bank accounts and receive funds. He also congratulated Clerk Harris on his reappointment. He then asked if Bill Phillips could attend the meeting with the Borough and the DEP.

Chief Vasto – asked about the status of the plans with Borough Hall. He wanted to know if there was a timeline for making a final decision as to which way they are going to go.

Councilman Dellosso asked if there was anything the Borough could do to speed up the remediation happening at the old Leon's site on First Ave.

ORDINANCE 05-2008

CALENDAR YEAR 2008

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Atlantic Highlands in the County of Monmouth finds it advisable and necessary to increase its CY 2008 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5 % increase in the budget for said year, amounting to \$45,280.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Atlantic Highlands, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2008 budget year, the final appropriations of the Borough of Atlantic Highlands shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$158,480.00 and that the CY 2008 municipal budget for the Borough of Atlantic Highlands be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, is filed with said Director within 5 days after such adoption.

Council member Archibald introduced this Ordinance and, after First Reading, moved for approval. It was seconded by Council member Dellosso and approved by the following vote.
