#### **MAYOR'S MESSAGE:**

### 1 January 2013 - Mayor Frederick J. Rast III Speech

This is the start of my sixth year in office. I have been lucky enough to have the same six Council people working with me continuously. This is probably a FIRST in Atlantic Highland's history. The last five full years have been interesting:

- I have married over 45 couples.
- We have been able to obtain over six million dollars in grants for town improvements.
- We have been in the news as a town several times; in fact, we made the "New York Papers" early on 1 about the Pot Belly Pig Law changing. .. a good thing!
- Unfortunately, we have been on NY TV and in the press due to Hurricane Irene and Tropical Cyclone Sandy ... not such a good thing.
- We have accomplished many tasks during these past five years: Skate Board Park, Junior Soccer Field, Henry Hudson Trail, reinstituting our "Skating Rink" in the Harbor, Building the new library and renovated the old Borough Hall ... all done where it should be done ... in the center of Town.
- Set up "Swift Reach," our reverse 911(which has our own self proclaimed Frank Sinatra-our Chief) as it official voice.
- $\bullet$  Improved our water supply system by FIXING our wells and we are drilling a 4<sup>th</sup> replacement well to protect our Town's water supply.
- We have survived major snow storms, a nor' Easter, a hurricane, a cyclone, an earthquake and several total power outages and major landslides. Each time, we as a town have been faced with such challenges; we came out of the disasters stronger and more efficient.
- We have had a large turnover in our Police Department and now have the youngest force we have had in years who due to their leaders believe in "Small Town Policing"
- We have lost several good friends and former officials in our community. We will miss them!
- We have helped our surrounding Towns in many ways- supplied water to people who had none and hundreds of our citizens volunteered to help the victims of the storms.
- We have provided and will continue to prove Shared Services with our neighboring towns. We intend to expand this program. Whenever I attend meetings with county, state and other town officials, I am proud to hear them speak of how well Atlantic Highlands runs. I would love to be the reason we run so well but I am not. Our Council is a great group of professionals that all put Atlantic Highlands well being FIRST in their minds.

We, the Mayor and Council look good only because we have, in my opinion, the finest Borough Administrator, Borough Clerk and Department Heads in New Jersey. They, in turn, could not have a better group of employees producing for them. Our employees are very hard working, underpaid (for the most part), dedicated people who have this Town and it citizens FIRST in their minds.

I learned many years ago in the Military that, "The mission comes first." However, as a young Sergeant and eventually a Second Lieutenant, I received advice from a great Two Star General, Howard Lauderbach. He

always told me, "The mission does come first, but you will never accomplish the mission without the respect, support and loyalty of your soldiers."The welfare of employees must always come first and then the mission you tackle will be done!

Leaders must think of ideas, develop facts, ask for input from their advisors then make a decision and act immediately. Thankfully all of our Council Members and Department Heads follow this concept. This is why our Town runs so well. We are blessed to live in a community with seven churches with spiritual leaders who love our citizens and our Town. We are equally blessed by the SPIRIT of volunteerism that exists in so many of our people. We have hundreds of volunteers; many protect us such as our Fire and First Aid Departments. Then we have so many organizations that all do well for our community and mankind. We have a great school system run by an excellent leader.

The only negative comment I will make is that often some and I emphasize "some" of our citizens' hide behind their computers and send out hate messages with no merit. The rumor mill is rampant. .. Some people do not make the effort to find the facts, they just make up stories or for one reason or another want to cause distrust or dislike for others. I am often the target. .. me or the Council. The Council and I are big boys and can handle it but these false, misleading and in some cases vicious attacks on people do nothing positive for our Town.

If people attended Council Meetings on a regular basis or even tried to obtain the facts, things would be much better. Many of the volunteers I spoke to have been unfairly criticized by some of our people who also did not have the facts. Several people have withdrawn themselves from future volunteer efforts. This is a shame. I wish that those who are so quick to criticize things without facts "would stop." I applaud Donna King for volunteering to assume the Chair of the Fireworks fundraising effort so that the Town tradition can continue.

Please. .. Those of you who are not involved ... "jump in" and become part of your Town. Don't just criticize, become part of the management of your Town. God bless you, your families, our Town and our Nation.
