



ORDINANCE 12-2010

ESTABLISHING A MUNICIPAL PARKING LOT ON EAST HIGHLAND AVENUE; BLOCK 99 LOT 14

WHEREAS to ease parking along surrounding streets, additional parking spaces will be required to replace lost spaces due to the new addition and reconstruction to Borough Hall,

NOW THEREFORE BE IT ORDAINED by the Governing Body of the Borough of Atlantic Highlands, in the County of Monmouth, State of New Jersey that Block 99 Lot 14, located on East Highland Avenue is hereby designated a Municipal Parking Lot and the following parking rules, regulations and restriction are hereby applied thereto and shall be posted on a sign at the entrance to said parking facility stating the same:

This parking is reserved for employees of the Borough of Atlantic Highlands between the hours of Hours 8:00am and 4:30pm, Monday through Friday. Any violators will be subject to towing and a fine not to exceed \$100.00

All Ordinances or parts of Ordinances, which are inconsistent with the terms of this Ordinance, be and the same are hereby repealed to the extent of their inconsistency.

This Ordinance shall take effect after its passage and publication according to law.
