Meeting was called to order at 7:00 P.M. with the following roll call:

CORRESPONDENCE:

Mrs. Frotton read letter from Atlantic Highlands Community Events Committee requesting the commission take an ad in the journal for the Mayor's Ball. Mrs. Marchetti offered a motion to take an ad on the inside front cover, seconded by Mr. Hoffmann and upon roll call was unanimously carried.

COMMITEE REPORTS:

CLEAN MARINA:

Mrs. Marchetti led a discussion on dumpsters. She asked that they be emptied more often, power washed and deodorized. She also led a discussion on the "short cut" behind the restaurant which is used by commuters to get to the parking lots.

Mr. Amici advised the area would be cleaned up and fencing installed.

ADMINISTRATOR'S REPORT:

Mr. Hubeny reported a grant has been received from Homeland Security in the amount of \$195,000 to be used for security cameras. The County will do the bidding for the project and will not be in effect until February or March of 2011.

Mr. Hubeny advised the movie from the State Library "Greetings from the Jersey Shore" will be shown at the harbor on August 12, 2010.1

ATTORNEY'S REPORT:

Mr. Corodemus reviewed memo from Mrs. Cassese regarding customers in arrears. He will begin legal action on those customers who still have not made payment in full.

HARBOR MASTER'S REPORT: The Harbor Master's report is on file in the Harbor Office for reference. Mr. Bate reminded the Commissioners that rates for 2011/12 need to be set as soon as possible.

ASSISTANT HARBOR MASTER'S REPORT:

Mr. Amici reported on proposed renovations to the exterior of the yacht club and is waiting for labor prices. He is also in the process of securing the entire storage yard with fencing. A dispenser containing plastic bags for fish remains has been placed by the fish cleaning station near Pier 7.
