Committee Reports:

- **Youth Soccer** – 250 kids registered. Draft will be held on August 20 at 7pm at Highlands Rec Center. We have enough coaches and referees. T-Shirts were ordered through Skip's in Long Branch. They came in with best bid by a couple of dollars!! 7 & 8 year olds will play at Center Ave and 5 & 6 year olds will play at smaller end of Fireman's. Need to watch drainage at Center Ave Field. Darlene was there right after rain and there was A OT of water but maybe sprinklers were left on. Open league for older kids was cancelled – not enough interest. Kavoojian Field will not be used for games. Too many complaints from parents and it is a mess. HES will be used for practice but all games in AH. Snack Shack bathrooms have been OK'd for use per SHLL. UK Elite was looking to host a 2-day soccer program.
- **Basketball** – Building Use will be heard at upcoming Board of Ed meeting. Still discussing custodian pay for Saturdays. Not sure if they must be a Black Seal? Board of Ed Employee?
