Mayor Rast delivered the following message to the residents of Atlantic Highlands:

My fellow residents of Atlantic Highlands, this first year went by so fast I cannot believe it! It seems as though we just got started. However, I have been blessed to work with a council of honest, God fearing, town loving individuals. They have truly made my job much easier!

Government moves very slowly, restrictions are placed on everything we do in Government when we try to get things done. In my opinion, the cumbersome roadblocks in place by Federal, State and County rules and regulations, really were created to make jobs for those who lobbied the politicians. If the private sector were restricted and regulated as much as Government is, nothing would ever get done on time or at Budget costs.

In spite of these roadblocks, our council team, working together in a non-partisan manner, we were able to get a few things done. Those projects we started but never finished was not due to lack of trying or our hard work. Your council and our professionals in Borough Hall, are a hard working team. We were successful in many things, However! We were able to protect our people's water supply system by repairing one of the two wells that were down and repairing the million-gallon water tank before a disaster occurred. We still must drill a new well to replace the old well, that is over 100 years old and no longer can be used.

We were able to find a truly economical way to institute our town's reverse 911 emergency warning system (which still has some bugs to be worked out). First estimates were for over \$30,000.00 to set up. We got it for less than \$5,000.00 per year, plus in the near future we may be able to tie into the county's system.

We were able to install and complete the Skate Board Park, as promised to our residents for many years.

The Bayshore Trail is nearly completed in Atlantic Highlands. We still need to complete the trail through our Fireman's Field that has been delayed due to environmental restrictions and pending litigation with the Gas Company.

We have greatly reduced the ground water infiltration into our sewer system, thus saving thousands of dollars by reducing the amount of liquids and solids treated by the Middletown Sewer Treatment plant. Simply put, we have been paying for clean water metered as sewerage, when it is piped to Middletown. We pay a lot of money treating clean water as though it is sewerage.

We have, through our hardworking committees and volunteer groups, been able to improve the quality of life for our residents by keeping the fireworks, the Fireman's Fair, Holiday decorations lining our streets Memorial Day Parade and many other things. Our Chamber of Commerce has been revitalized by an inspired leader and the support of our elected officials, who actively and aggressively support the many businesses in town.

Although we cannot allow Scouts and other youth groups to camp in Lenape Woods, we <u>are still</u> working on it! The real delay is from Middletown Township, who still has not decided if they are going to relinquish full control of the wooded area, mainly within their town but owned by Atlantic Highlands to us, so we can allow camping. It seems their town does not allow camping, so we cannot, until we have full control of the land we paid millions of dollars for! Two private owners would take a couple of days to make a decision, instead of 8 months!

We finally are making progress in fighting the mold in Borough Hall. We think the most sensible and economical way to correct our mold problem in Borough Hall, as well as build a new library is renovating the existing building with a sensible addition.

Due to the new State and Federal regulations the cost of building a new Borough Hall and Library, would prove to be an astronomical amount of money. If we renovate, correct the moisture problem and expand the existing structure, those regulations will not apply and will cost us much less to get the job done.

We have stopped political interference in our various utilities, commissions and committees.

In Borough Hall's operations, by allowing the professionals to do their jobs without micro managing from our council, morale has increased and so has productivity.

Since Jan 1, 2008, I have insisted that no one except <u>current elected officials</u> and town employees are allowed in the Borough's work areas. The heads of the various commissions, utilities and committees, are allowed access to confidential papers and workspace of our Town Hall, on an as needed basis only!

On Day One, Jan 1, 2008 I had locks and codes changed and demanded that no more political petitions be allowed to be on the counters of Borough Hall. In the past such petitions implied that the town officials were endorsing one political view or another.

No longer are we allowing the town quarterly newsletter to be a venue where the political views of the Mayor and Council members are expressed.

I have reminded everyone that the Council and I were elected to serve equally, all of our town's people, regardless of their political affiliations. We will not subject our citizens to our own political views, while in our official capacity.

Our team has set goals to support the bringing back of old "Hometown Traditions" that made us, as long time residents of Atlantic Highlands, love our community so much. The Santa Clause rekindling by the First Aid Squad has brought joy to all. The direct involvement of our Mayor and Council brings back memories I have, with Mayors Waldron Smith and Everett Curry visiting my home when I was a young boy, along with Councilman as Elves during Christmas time.

We are trying to set up an "old tradition" of ice-skating in the harbor. Mother Nature has not cooperated yet and we have had some technical problems.

Next year, I would like to find some place in our town where we can have a <u>safe sledding hill</u>. When I was a child, Mount Avenue was always blocked off during heavy snows. I am not suggesting we do that again but I bet we can find some private land, some place where we could at least have a "kiddy hill" safe for the little ones to enjoy. <u>After all</u>, our children are our greatest asset.

We are in very hard economic times. It has dramatically hurt all of us. God only knows when it will get better but at least Atlantic Highlands can remain an oasis, where people can enjoy life, raise their families, be protected by our fine Police, Fire and First Aid personnel and be thankful they have this lovely community to come home to at the end of the day.

The only promises I make to our people, is that the Council and I will continue to serve all of you, without prejudice, malice, political slant and on the high moral ground, to the best of our ability.

You know we have seven churches in town, their clergy do wonderful things for our community. I ask them all. To pray for us as elected officials, to give us the guidance and strength to do the best job possible for our community.

God Bless you and your loved ones and God Bless and keep our United States strong and safe for all of us and our children.

DEFINITIONS

- Chief Financial Officer shall mean the person appointed pursuant to section 5 of P.L.1988, c.110 (C. 40A: 9-140 10
- Fiscal Year shall mean the period for which a local unit adopts a budget, as required pursuant to the "Local Budget Law," N.J.S.40A:4-1 et seq.
- 3. <u>Cash Management Plan</u>, pursuant to N.J.S.A. 40A:5-14, each local unit shall adopt a cash management plan and shall deposit, or invest, or both deposit and invest, its funds pursuant to that plan.

DESIGNATION OF DEPOSITORIES

The following financial institutions are designated official depositories:

Wachovia Bank
TD Bank
Bank of America
Valley National Bank
Two River Community Bank
Investors Savings Bank

Designated official depositories are required to submit to the Chief Financial Officer of the Municipality a copy of the State of New Jersey, Department of Banking, Governmental Unit Deposit Protection Act notification of eligibility, which must be filed semiannually in the Department of Banking as of June 30th and December 31st of each year. Said notices must be available for annual audit.

DEPOSIT OF FUNDS

All funds shall be deposited within forty-eight hours of receipt to maximize interest earnings.

Operating funds shall be deposited into interest bearing accounts to maximize interest earnings. Capital and debt service funds may be deposited into interest bearing accounts. Trust Funds may be deposited into interest bearing accounts in accordance with the State statutes regulating the Developer's Escrow deposits. Non-interest bearing accounts should be regularly monitored for availability of funds for investment except where either State or Federal Laws prohibit the earning of interest on such funds.

AUTHORIZING SIGNATURES ON CHECKS

The following Borough Officials are hereby authorized to sign checks where a combination of three (3) principal signatures is required:

AUDIT REQUIREMENT

The Cash Management Plan shall be subject to the annual audit conducted pursuant to N.J.S.A.40A: 5-4.

AUTHORITY TO INVEST

The Governing Body shall pass a resolution at its first meeting of the fiscal year designating the Chief Financial Officer, who shall make and be responsible for the municipal deposits and investments.

INVESTMENT INSTRUMENTS

The Chief Financial Officer shall invest at his/her discretion in any investment instrument as approved by the State of New Jersey in accordance with N.J.S.A. 40A:5-15.1.

REPORTING PROCEDURES

The Chief Financial Officer shall report all investments in accordance with N.J.S.A. 40A: 5-15.2.

At a minimum the Chief Financial Officer shall:

Keep a record of all investments.

Keep cash position record, which reveals, on a daily basis, the status of the cash in its bank accounts.

Confirm investments with the Governing Body at the next

regularly scheduled meeting.

Report monthly to the Governing Body as to the status of cash balances in the bank accounts, revenue collection, interest rates and interest earned.

CASH FLOW

The Chief Financial Officer shall ensure that the accounting system provides regular information concerning the cash position and investment performance.

All monies shall be turned over to the Chief Financial Officer and deposited in accordance with N.J.S.A. 40A: 5-15.

The Chief Financial Officer is authorized and directed to invest surplus funds of the Borough of Atlantic Highlands as the availability of the funds permit. In addition, it shall be the responsibility of the Chief Financial Officer to minimize the possibility of idle cash by depositing the monies in interest bearing accounts wherever practical and in the best interest of the Borough of Atlantic Highlands.

The Chief Financial Officer shall ensure that funds are borrowed for Capital Projects in a timely fashion.

RESOLUTION 017-2009

SETTING GRACE PERIOD, INTEREST RATES AND POLICY FOR TAXES AND MUNICIPAL CHARGES FOR 2009

WHEREAS, N.J.S.A. 54:4-67 permits the Governing Body to fix the rate of interest to be charged for nonpayment of taxes or assessments subject to any abatement or discount for the late payment of taxes or assessments as provided by law; and,

WHEREAS, any unpaid taxes and municipal charges constitute an unfair burden on those taxpayers who pay their taxes and municipal charges in a timely manner and delinquent taxpayers should be required to carry their share of the tax burden; and,

WHEREAS, N.J.S.A. 40A: 5-17.1 allows for the cancellation of property tax delinquent amounts or refunds in the amounts of less than \$10 and allows the Governing Body to authorize a municipal employee to process this cancellation at the end of the tax year,

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Atlantic Highlands, County of Monmouth, State of New Jersey, that the tax year 2008 is closed effective December 31, 2008 and that property taxes shall be due and payable quarterly on February 1st, May 1st, August 1st and November 1st for the year 2009, with a ten-day grace period, after which dates, if unpaid, shall become delinquent, with interest charged as set forth below and reverting back to the due date on any quarterly installment of taxes. The Tax Collector is hereby authorized and directed to charge, subject to any abatement or discount for the late payment of taxes as provided by law:

- 1. Eight percent (8%) per annum on the first \$1,500 of taxes delinquent after due date; and,
- Eighteen percent (18%) per annum on any amount in excess of \$1,500 delinquent after due date; and,
- 3. An additional penalty of six percent (6%) shall be added to any taxes, interest and municipal charges in excess of \$10,000 that remain unpaid at the end of any calendar year. This shall be calculated on the sum of all taxes from year to year and not on an individual year basis.
