THE PREMISES in question are in the HBD Zoning District, Tax Map Block 97, Lot 5, more commonly known as 96 First Avenue, Atlantic Highlands, Monmouth County New Jersey 07716.

THE APPLICANT IS SEEKING. The applicant will seek Bulk-Variance Approval, additional interior use to the first floor of the existing building. Activity center is ancillary to the principal use, rather than an additional use.

- 1. Relief from the following:
 - a.) **Section 150-29(A)(2)** –The minimum lot area required in the HBD zone is 4,000 sq-ft, whereas the existing lot area is 1,562 sq-ft.
 - **b.)** Section 150-29(A)(2) —The minimum lot frontage required for interior lots in the HBD zone is 35 feet, whereas the existing frontage is 25.07 feet.
 - c.) Section 150-29(A)(2) —The minimum lot shape diameter for interior lots in the HBD zone is 30 feet, whereas the existing lot shape diameter is 25 feet.
 - d.) Section 150-29(A)(2) —The minimum gross floor area for the first floor of a muti-story building in the HBZ zone is 1,500 square feet, whereas the existing first floor area is 1,296 square feet.

AND for such other variances and design waivers as may be required by the board.
