2. Minutes: BS makes motion to approve August minutes, BT seconds, all in favor
3. Correspondence –
 - a. Several removal permits, some even include stapled plans/photos, one is a crown thinning, one relates to a septic with no replacement/fee and another notes “garbage trees” (AC will look further into those), overall these are slightly better filled out with better accountability
 - b. 3 planting requests, JG’s neighbor may be convinced to add another; there are 3 emails and perhaps another paper request
4. Treasurer’s Report – \$14,170.27 is the opening balance, \$29,170.27 is closing balance
 - a. No expenses
 - b. Annual budget check for \$15,000 deposited
 - c. BT motions to approve; AC seconds; all in favor
5. Old Business –
 - a. Tree List: FG shared version 1, only Larger Trees for now, needs others on team to check for errors, will format and add links after reviewing process; Evergreens and Smaller Trees to be added; we can print copies for front desk/library
 - i. AC makes a motion to publish on website once edited/finalized, BT seconds, all in favor
 - b. CMFP and Grant: AC and FG re-began the process of the grant application, will need EC to provide some documentation and banking information from BS
 - i. AC also emailed about potentially needing an extension, no response yet
 - ii. Need to work with Davey on actual plan/document to provide content
 - iii. Davey has not invoiced us yet

- c. Tribute Trees: We will start circling back to this soon with fall plantings
- d. Fall Planting: We have ~7 applications so far, does anyone on the commission want one (EH might)
 - i. Suggest going with Fernbrook again, all inclusive pricing with planting, prices are similar to last year, tight and specific tree list including some natives, one year guarantee (we should check on last year's plantings before year is up)
 - ii. We would need to procure/spread mulch (we could ask the borough to use the mulch they keep in the yard)
 - iii. Fernbrook would like the order by the end of October but this small quantity is probably flexible, EC will announce at council meeting and BT will repost flyer, should we share printed flyers anywhere?
 - iv. We can add elms behind Wells Fargo on Wells/Hennessey; the Liberty Tree (July notes) is supposed to be an elm
 - v. We can budget for around 20 trees
 - vi. EC will check on the funds from tree permitting and replacement (where is that money); this is different money than borough funds as it comes from residents, this should be coming to us as the borough tree planting service; how much is there? What is the cadence and process?
 - vii. BT makes a motion to approve tree planting budget of \$8,500, BS seconds, all in favor
- e. First Avenue Redesign: AC will piece together aerials and EH/JG will inventory/layout what is currently there and the number of wells
 - i. We can begin planning and budgeting, plan to expand wells and protect trees, replace/improve soil, etc.
 - ii. This is a big expense and a tough area for healthy trees but will beautify and extend the sidewalk/right of way area
 - iii. We will need county approval/buy-in (there may be a partnership or grant opportunity with the county)
- f. Tree Removal Permits: AC shared new draft of form with new information fields and office use only section; BS motions to approve it, BT seconds, all in favor
 - i. This form should be both on STC page and code enforcement page
 - ii. Tabling the permit tracker spreadsheet for now
 - iii. Sherri did respond to AC's request to have her do the inspections for us

1. He wants to remove DBH from form so he can measure and fill out himself and they want to keep a loaner tape at borough hall, he can add that information to an “Office Use Only” section
2. Should we get a couple of these tapes to keep at borough hall/the library so people can try to accurately measure trees on their own
3. RC wonders if we actually have the power to dictate what residents do to their trees? He showed AC/BT the ordinance that says we do not in a state code/rule book; he also said he can’t suggest pruning because he and the town will be liable if something happens (though he shouldn’t be worried about individual liability) and if a tree removal company puts their license on the line saying to take a tree down we should adhere to that (that said, tree removers are incentivised to remove whole trees and not branches)
 - a. Is there someone else that can do this?
 - b. Who does this work in other towns? Fairhaven pays Sherri to do this. AC will ask Sherri how much this would cost once or twice a month estimating the number of permits? It feels worth spending less on tree planting or other expenditures
4. Did not to talk about tracking (Beth was unavailable) but in Fairhaven the STC secretary does the tracking
 - a. AC believes the borough should own at least some of this
 - b. An online PDF or Jotform would automatically track this information
5. Rob said we can attach something to the permit or add a second page with information from Rutgers on how to save your tree/avoid taking it down
 - a. We can each do some research on this: Rutgers, University of Oregon, Arbor Day, etc. – resources on how to save your trees, removal versus anything else, questions you can ask your arborist/tree service

17. Guest, Paul Marcontell, Sons of the American Revolution (SAR) talking about their [Liberty Tree](#) initiative
 - a. A voluntary program to commemorate the 250th anniversary of USA with planting tree
 - b. Based on the original "Liberty Tree" in Boston, a place where colonists/patriots gathered; the British took this tree down but it was replanted
 - c. PM is unsure of funding but believes there may be some help/conduits through SAR/DAR; if a tree is planted SAR will provide a plaque
 - d. Trees would be a disease resistant "Princeton" elm, 7-10' tree would be good
 - e. Fairhaven, Highlands, possibly Rumson and Middletown are getting involved

2. Minutes – will push approval to next month since they were late going out; FG will resend May along with June so it's all in one place

3. Correspondence —
 - a. Mailer from SavATree about free consultations to test for leaf scorch
 - b. Notice from RC with note received at June Council Meeting regarding town-owned lot on Ocean Blvd. (where old railroad ticketing station used to be)
 - i. Lot is overgrown, ivy is growing on trees, some dead trees (neighbors are most concerned by blocked views); they want "cherry and dogwood trees"
 - ii. Trees might need a trim and new trees/understory trees can be added, the borough already did a light cleanup the day after the meeting
 - iii. Signed by many neighbors
 - iv. AC will look at it, in-person, with Sheri (EC may join)
 - v. AC will update RC and he will speak to resident point person
 - c. 4 removal permits: Asbury Avenue is using Tree Masters, a company that may not be on our approved list) to remove a "dangerous" tree (no replacement), no species or size included; another on Asbury does not have enough replacement trees listed (should be 4, listed at 1); another is "dead" with fall potential, even though owners said they were willing to pay into the tree fund, RC said that was unnecessary
 - i. CFO knows how much is in tree fund, VC will look into it(EH confirms that the ones she took home have no information)
 - ii. We need to speak with RC about making sure the information is present and the approved companies are used; he should be adding missing photos, sizes, etc.

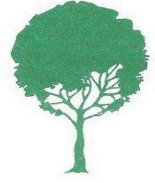

- iii. EH/UP will take some home to try to create a system to compile/log these/EH will create simple/sample spreadsheet (address, species, size, dead or not dead, replaced or not, date)

5. Old Business —

- a. Tree List: FG chipping away at spreadsheet, spreadsheet/draft hopefully in June
- b. CMFP: Inventory is complete/paid for; FG/AC to meet and discuss the grant
 - i. AC is working on Tree Keeper app/login (Davey extended the access availability) which will map and filter the information, Davey can give us a short demo but the subscription is over \$3000/year which is very high and we likely we will not use this effectively
 1. What is ROI? What are we doing with our inventory? If it's for knowing what to plant when based on age and species, this should work alongside permit database to be a full picture of trees and tree losses; inventory is paid for

- d. Tribute Trees: Placeholder, no responses on open applications/requests, BT received one new application and will forward

- a. Watering and Maintenance on Trees Planted Last Fall: There were 7-8 public trees (two at South Avenue park, two on Hennessy behind Wells Fargo, one at East Avenue Park, one or two on the trail)
 - i. AC will check with Jimmy to confirm they all have gator bags and what frequency and availability he has to water (need this info to begin requesting/scheduling);
 - ii. AC will also check with MT for the online form and volunteers signed up to water trees

 - iv. We need to develop and cadence and provide general instructions

1. This refers to non-dangerous trees: They are doing work/spending money to remove healthy trees
2. RC measures those trees and that will dictate how many new trees need to be planted (within one year), or they pay into tree fund
 - a. AC will get a proper tree measuring tape for RC
3. They have one year to take down, one year to plant, and two years of tree inspections after that (to make sure tree is alive)
 - a. Trees will be checked in spring (did they survive winter) and in high summer (how are they surviving the heat)
 - b. Replacement trees need to be selected from recommended trees list
4. Only one person has paid into tree fund so far (they were illegally cutting down trees and got tickets), that was \$1,400
 - a. It is not RC's job to notify when money is in account
- vi. Historically there is a lot of "topping," the ordinance says it's no longer legal
 1. A lot of people are angry about this bc they think it used to be legal; but many did not ever have permits
- vii. You can trim up to 15% of tree, and must trim conically (for the health of the tree and for aesthetic purposes)
- viii. Steep slope zone tree removals require steep slope review
 1. There's a fee for this, plus compounded costs of tree work
- ix. Per arborist, if a tree maintenance company has a CTE license then we have to accept their diagnosis and a tree they deem unhealthy can be removed without fees
- x. All of this is how ordinance reads and is for liability/to avoid danger
- c. RC says that leaning/sloping trees must come down, AC wants him to refer those to the arborist and RC said we have to go through borough administrator for that
- d. RC's areas of concern:
 - i. Bayside/Pompomora Point – this is area is under multiple auspices (private/town/county) so it is complicated, there have been mudslides, the arborist is supposed to physically visit, costs will be high with steep slope reviews
 - ii. East Highland from Grand to Ocean (there is a borough property here), arborist was asked to look at this
 - iii. Third near Wesley, East Garfield to First – old sycamores shedding branches daily, damaging sidewalks/roads
 1. In this case owners are advised to paint sidewalks orange and replace
 2. Replacing sidewalks may kill old or new trees anyway
 - a. We can suggest but not force people to bump out or slope sidewalks to protect trees
 - iv. Someone is going to sue brough (dangerous sidewalks, not being able to remove trees, a tree we say is safe comes down)

 - a. We asked SS about the Green Communities Grant
 - i. It is available to and handled by STCs via SAGE (The New Jersey Department of Environmental Protection (NJDEP) SAGE system for submitting grants for the New Jersey Urban and Community Forestry Program (NJUCF)
 - ii. Maximum grant is \$20K and town must match 25% of the grant, if AH receives a grant of \$20K the borough will pay \$5K out of STC budget

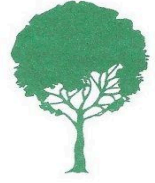

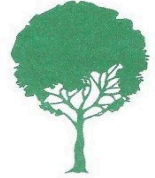

Some of the trees on their list are native to the Southeast; we might need to look into trees that are zoned for below us/native to southern areas so these trees can survive hotter temperatures (Princeton University is now selecting new trees from the Virginia/Maryland area); note that our newer native dogwoods in town that don't seem to be doing well
- ii. We need to select narrower/smaller trees/shrubs for First Avenue (the snow goose cherry and the dogwood on the list might be a good fit here) that can work under wires; there are 7-8 spots plus replacing the shrub by the Thai restaurant

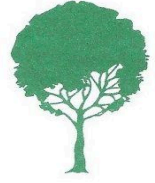

Very good turnout for sapling giveaway, perhaps thanks to social media posts; “consumers” were well informed and came up knowing which trees they wanted and Frank Gargione and Ben Schmoll gave away ~200 of ~250 trees; remaining trees were set up outside Jaspan’s or brought to the AH Arts Council for the speaker event; Jaspan’s is happy to have us set up outside the store next year; saplings were healthier, larger, and better packaged this year so Bartlett Tree Experts should be reached out to again next year

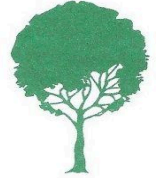
28. New Business

- a. Watering schedule: All new plantings from 2023 and 2024 on borough property should be watered
 - i. Gator bags and troughs should be with Jim (don’t have last name); Vito Colasurdo will check in with him and see if he still has materials and is willing to take on watering with brining truck
 - ii. Alternately, Mary Trank has a volunteer schedule template that Ashley Cruz will reach out to her about — if Jim cannot manage watering the Commission will need to set up a system
 - iii. A Google map plotting tree locations should be created
 - iv. Related: Ken and Fred (don’t have last names) have added a plaque to one of the new Serviceberries at Center Avenue Park, these trees look good, a third with another plaque looks less healthy — should the plaque be moved? Will any of these trees survive the park renovation?
- b. Tree planting
 - i. - iii. Species List: An effort should be made to winnow down the [Monmouth County list](#) of recommended trees into an AH-specific list something like the one shared by [Fair Haven](#); think about trees that are healthy and beneficial in our area; conversation to be continued
- c. Big Tree Hunt: Bill Thorne added this to the Facebook page; the Commission should consider local trees for inclusion; as an aside — should we encourage residents to share photos/stories of their favorite trees or updates on trees procured at past AH sapling giveaways to share on Facebook or in newsletters?
