## Minutes: Borough of Atlantic Highlands Shade Tree Commission for Feburary 9. 2010 Meeting Tuesday, April 13, 2010; 7:00pm

The meeting was held at Atlantic Highlands Borough Hall, 100 First Avenue, Atlantic Highlands

Louise Donoghue called the meeting to order at 7:05 PM.

Old Business: The accomplishment report for the grant was discussed. Joe Hawley reported that he mailed the report as was requested of him.

An e-mail from Ken Thoman regarding the tree cutting that took place in front of the Hoffbrau was read and filed. The trimming was not done as suggested by the committee. Discussion followed with Jennifer Marston and Lois Young suggesting that the Committee do more public education about trimming and about the Steep Slope Ordinance.
