The consultants will email the final draft by August 25, 2015. The management plan will be finalized at the meeting on September 8. The consultants will make 6 hard copies and 1 electronic. The STC is responsible for submitting the management plan to the state by October 8, 2015. Two signed copies, which will need the mayor's signature, and one electronic, are for the state; the state will send the plan back.

The Minutes from the June meeting were reviewed and a motion was made by Bill Thorne and seconded by Fran Hogan. All in attendance voted in favor of acceptance.

Treasurer's Report: Bill Thorne distributed the Treasurer's Report. The closing balance in the account was \$10,281.94. The budget is attached to the minutes. Louise Donoghue made a motion to accept the report, which was seconded by Kate Wigginton. All voted in favor of acceptance.

Old Business: Marilyn Scherfen and Kate Wigginton looked at trees in distress and found six or seven that had to be removed. Marilyn is looking into a tree removal company.

Tree Tubelings: Were given away at the farmers market and the rest were given to the elementary school. None remain.

New Business: Hospitality: Fran Hogan will put together a schedule of people to water trees. There will be a sign-up sheet at the farmers market. There will also be a donation box.

Yes vote for the new logo that Mike Scherfen designed. Bill Thorne made the motion; Fran Hogan seconded it. All in attendance voted in favor.

An extra meeting will be added to discuss the management plan. The date put forth by Marilyn Scherfen was Wednesday, August 5 at 6:30 P.M. Mrs. Scherfen will send an e-mail to the members confirming that date.

A motion was made to adjourn the meeting at approximately 10 P.M. by Louise Donoghue, seconded by Fran Hogan and accepted by all those present.
