Page 22: Add to first paragraph: ..."as well as outreach."
Motion to approve the Five Year Management Plan contingent on changes made by Mary Wall seconded by Kate Wigginton.

None of the Shade Tree Commission will get CORE training this year. We will send members next year. Lori Montana will ask Mary Thompson about getting a credit since Fran Hogan wasn't able to attend last year. (Note: Lori Montana spoke to Mary Thompson and we will not be able to get a credit.)

New Business: Fran Hogan approached several businesses in town and many have said yes having a STC donation jar during the Taste of Atlantic Highlands. Fran showed the commission the jar she designed. Everyone agree she did an excellent job! Fran will give the jars to the establishments on Friday and collect the donation jars on Sunday night. She will deposit the money on Monday

Bill Throne will send information to the Beacon for their next edition. The deadline is November 6. Dwayne will put it on the calendar. We will talk about the article for the Beacon at the meeting in October. September 19, is the Atlantic Highlands Historical Society Flea Market. Fran Hogan will sit at the table during the event. We will charge \$2.00 for a magnet. Fran will donate the magnets.

She will also talk to Adam about letting the PWD men stay for refreshments after the tree planting. Louise will MC, order the tree, and the invitations. The tree planting will take place on Thursday, October 15 at 10:30 A.M. at West Highland and Hennessey Boulevard at 10:30 A.M. in honor of the of the Public Works Department.

Lori Montana left the room and it was agreed that she, as the new secretary, will be paid \$50.00 a month even in months when the STC doesn't meet plus supplies, if needed. All agreed including Lori Montana.
