### **New Business**

The Atlantic Highlands Garden Club is disbanding and would like to plant a tree in honor of the Club. The commission members discussed having the Atlantic Highlands Garden Club be honored with the Fall Tribute Tree, and the Mayors' Tree, previously chosen for the fall planting, would be planted, instead, on Arbor Day 2017.

The design firm for the Carton Brewery renovation would like to involve the Shade Tree Commission in recommending street trees to plant in front of their new building on First Avenue. Trees discussed were: Trident Maple, 'City Sprite' Zelkova, and Japanese Lilac. Commission members are asked to submit any other recommendations by the end of June so they may be presented to the firm.
